
IQAC (Quality check mechanism)



- **1.** Administration: Maintaining the momentum of quality consciousness crucial in colleges. Internal Quality Assurance Cell, in fact, is conceived as a mechanism to build and ensure a quality culture bat the institutional level. The IQAC function is:
 - Development and Application of Quality benchmarks/perameters for the various
